

## **Tennessee Humane Animal League Pet Placement Center 2020 Raffle TERMS & CONDITIONS**

Raffle authorized by State of TN Division of Charitable Solicitations, Fantasy Sports and Gaming.

The Tennessee Humane Animal League Pet Placement Center 2020 Raffle (the "Raffle"), is conducted by Tennessee Humane Animal League Pet Placement Center ("PPC" or "Sponsor"). Your purchase of one or more raffle ticket(s) signifies your full and unconditional agreement to the following Terms & Conditions. In the event of any dispute, a reasonable interpretation or determination by Pet Placement Center Staff or Board of Directors regarding the application of these Terms & Conditions is final and binding in all matters related to the Raffle.

**VOID WHERE PROHIBITED BY LAW AND OUTSIDE THE UNITED STATES.** Subject to all applicable federal, state, and local laws, regulations, and ordinances. Tickets may sell out before the date of the raffle drawing. The chances of winning are based on the number of tickets sold. If fewer tickets are sold, the chances of winning improve.

### **Eligibility**

- To be eligible to purchase a ticket, you must be at least 18 years old or the age of majority in your jurisdiction of residence, whichever is older as of the date of entry, and a living resident of the United States. Officers, directors, employees of PPC, and anyone living in the same household as the aforementioned, are not eligible to win. The determinations of PPC are final and binding with respect to any matter arising out of the interpretation or application of these terms and conditions.
- A ticket purchased by an ineligible person is void, and cannot be a winning ticket. No refunds will be made to ineligible purchasers, except in Sponsor's sole and absolute discretion.

### **Tickets**

You must provide all required information to be eligible to enter and win. Incomplete, illegible, corrupted, or untimely entries are void and will be disqualified.
- A ticket represents a chance to win the opportunity to accept an offer of the stated prize. All sales of tickets are final, and no refunds will be paid.
- Tickets, prizes, receipts, and any winner's rights are not transferable.
- Sponsor reserves the right to reject any ticket reservation request that is submitted with payment that does not constitute "good funds." A ticket issued in exchange for a check returned for "insufficient funds," or for a credit card charge that was "declined," or reported as "invalid" or "stolen" is void, and cannot be a winning ticket.

## **The Drawing**

PPC will select the name of potential winners of the prizes in a random drawing from all eligible raffle tickets. All tickets have an equal chance to win. Ticket purchasers need not be present to win.

- There will be up to a total of 38 winner(s) selected in the Contest.

- •Each prize will be awarded to only one (1) winner. If the winner refuses the prize, an alternate winner will be selected by random drawing from among all remaining eligible entries. If the ticket has more than one name on it, the prize will be awarded to the eligible individual whose name appears first on the ticket.
